Because Ross is committed to continuing our long history of contributing to the community, our neighbors and our employees, we want you to know about our plans.

Ross is seeking the necessary permits and approvals to expand the footprint of our Giles Road operations. These permits and approvals will allow us to build a new treatment area and develop new technologies, including a monofill.

**HERE ARE SOME OF THE COMMON QUESTIONS WE GET ABOUT OUR PLANNED EXPANSION:**

**Q: WHAT IS A MONOFILL?**

A monofill is a type of landfill that only contains waste from a single operation. In this case, the waste disposed of in the monofill will be limited to inert incineration residuals from our current Giles Road incineration process.

**Q: WHAT HAPPENS TO THESE RESIDUALS CURRENTLY?**

Today, we transport residuals, materials remaining after incineration, to other facilities in the U.S. Relying on other companies leaves Ross vulnerable to possible disruptions in the business of those companies. Building our own monofill means we will be able to control all aspects of our process, which, in turn supports the long-term viability of Ross.

**Q: WILL THE COMMUNITY HAVE A CHANCE TO SEE PLANS, ASK QUESTIONS, MAKE COMMENTS?**

Yes. Ross is committed to continuing our long history of contributing to this community, our neighbors and our employees. That's why we want you to know about our plans and will share details throughout the permit application process. We have always maintained regular, open communications with our neighbors, community leaders, and our elected officials, and will continue to honor that commitment through this expansion process.

The permitting and construction will be carefully guided by various government and regulatory bodies, with formal public comment periods. And, we welcome your comments and questions at any time. **Q: HOW WILL THIS AFFECT THE NEIGHBORING COMMUNITY?**

This proposed expansion will bring a positive economic impact

to the region. The permit approvals we are seeking to expand our facility footprint and develop new technologies will allow Ross to grow in ways we simply can't with the current permits we have for our site. That expansion improves the long-term viability of Ross and allows us to continue to be a strong corporate citizen.

**Q: HOW WILL THE CONSTRUCTION AFFECT GILES ROAD?**

We don't anticipate that Giles Road will be closed for regular traffic at any point. We are committed to being a good neighbor and that includes not creating any traffic problems for our neighbors.

**Q: HOW SAFE IS THE MONOFILL?**

Ross has a proud history of safety and compliance in everything we do, and that commitment will continue through the construction and operation of the monofill. This project is being planned with safety as our top priority and completed with full regulatory oversight from the Ohio Environmental Protection Agency (Ohio EPA), and in compliance with regulations established by the Resource Conservation and Recovery Act (RCRA) and the Occupational Safety and Health Administration (OSHA), as well as any applicable state and local zoning and building regulations.



## Q: HOW LONG WILL THIS PROCESS TAKE?

Our neighbors can feel confident that every step of the planned expansion is guided and regulated by various agencies and authorized bodies, from the Zoning Commission and Eaton Township Trustees to the Ohio EPA and US EPA.

That means that there are many prescribed review periods, deadlines and checkpoints. As with most construction projects there are multiple variables, such as weather, resources and reviews. This is a general estimate and we will inform the community if the timeline changes significantly.
